

CCI embarked on a journey to bring clarity and insights into the ever-evolving realm of compensation of credentialed cardiovascular professionals.



Registered Cardiac Invasive Specialist (RCIS) Exam Content Outline

The CCI Board of Trustees approved a revised Examination Matrix/Task Outline for the RCIS examinations administered on or after July 1, 2024.

Duties and Tasks	Approximate % of RCIS Exam
A. Conducting Pre-Procedural Activities	8%
B. Conducting Diagnostic Procedures	40%
C. Conducting Interventional Procedures	34%
D. Responding to Emergency Procedures and Protocols	13%
E. Conducting Post-Procedural Activities Reports	5%

The examination content is based on the findings of a Job Task Analysis (JTA), which describes the overall tasks that an RCIS is expected to perform on the job and general areas of knowledge that are needed to perform the tasks. A JTA is performed every 5 years for all nine of the examinations that CCI offers to keep exams relevant to current practices in the field.
